Even though it has been several months since we reported on the ministry in Vietnam, our friend, *Li Su has been very busy with multiple ministry outreach projects that touch the lives of hundreds.



One of the teens at *Bethel is now learning to repair motorbikes.

She runs three children's homes which continue to meet the needs of forty precious children and young people. Several teenagers have been raised in the *Bethel Children's Homes and are now in need of transitioning out of the home. A generous Global Outreach partner has recently donated funding to provide vocational training for four of these young people.

The first one has started and is currently studying auto mechanics which will enable him to find a job repairing motorbikes. There are millions of motorbikes in Ho Chi Minh so this should be a good career for him. The other three will enter their training after the New Year which is celebrated in February.

*Li Su also continues her work among the 33 leper villages she has identified throughout Vietnam. Last year we were able to provide support for several special projects, including fifteen wheelchairs, a new well, a motorbike, renovations to a church, food and other supplies for these communities. Several more wheelchairs are now needed at a cost of \$75 each. Every time she visits a leper village, Li Su cooks for them and gives them rice and other food as well as clothing and other much needed supplies. These precious folks are ostracized and the government provides them very little support. We are thankful we are able to partner with her in this vital ministry, a true labor of love.

Another area of focus is visiting and teaching teens who are in a juvenile detention center. Li Su

would love to help them as they leave the center, but currently does not have the funds or space to offer the services that could change the trajectory of their lives. She is especially concerned about the girls who will be vulnerable to exploitation and abuse.
